### Commission, Rates and Other information

<b>Freight Rates</b>	All freight rates are in INR and are commissionable by IATA 5%.
<b>Charges Correction Fee</b>	INR 3200 for every amendment, if amended at agent's/shipper's request.
<b>POD Fees</b>	Proof Of Delivery fees INR 3200 per shipment ( exports).
<b>Dangerous Goods Fee</b>	USD 100 to be paid in local currency at the prevalent rate of exchange per MAWB for shipments requiring a shipper's declaration for dangerous goods. <b>Note :</b> DGR fees are applicable for shipments using Dry Ice (UN 1845) as a coolant for refrigeration. DGR in single packaging and cryogenic containers (Dewars) are not acceptable for carriage on EY unless overpacked
<b>Disbursement Charges</b>	INR 1000 or 10% of total amount, whichever is greater. Code to be reflected on the airway bill is DBC
<b>Valuables Security Handling Fee - SAFEGUARD</b>	Please check with your Relationship Manager / Reservations Team for the Safeguard Handling Fee according to your booking.
<b>Human Remains</b>	As per IATA regulation
<b>PER</b>	Kindly contact your Relationship Manager / Reservations team for pricing for Perishable cargo.
<b>Fast Track Cargo</b>	All Online destinations less than 100 Kgs will be flown as Fast Track Cargo (except DAR, EBB)
<b>Charges Collect</b>	Please keep the Reservations Team informed of bookings on charges collect. Charges collect shipments are not accepted for destinations served by our interline partners.
<b>FHL Charges</b>	INR 454 per MAWB and HAWB for manual transmission (CCC) for all destinations. INR 133 per MAWB and HAWB for automatic transmission (CGC) for freight destined to all destinations. FHL charges are applicable for both Consolidation and Direct shipments
<b>Export Freight Screening Charges (X-Ray)</b>	INR 2 per kilo on Chargeable weight and minimum charge being INR 225 /- . The same to be reflected on the airway bill as SCC.


